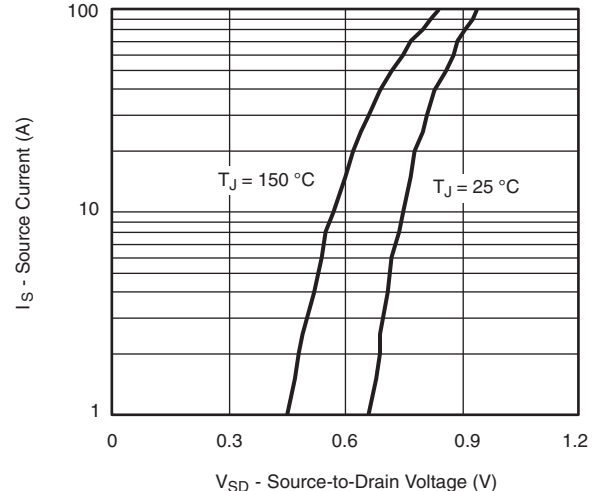

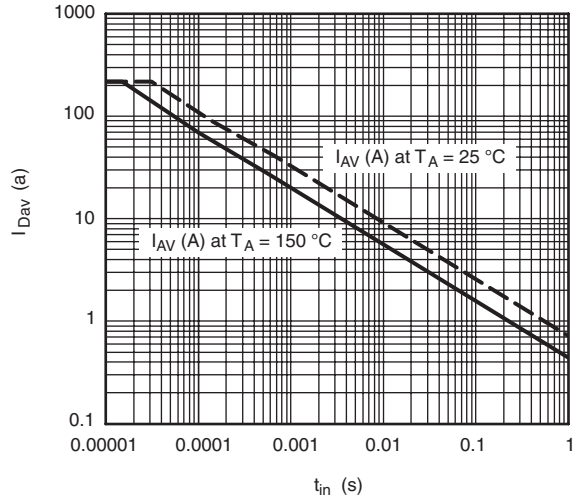

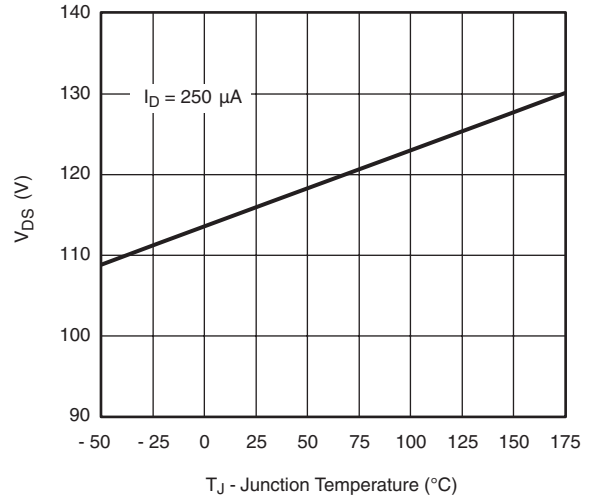
On-Resistance vs. Junction Temperature

T_J - Drain-Source Breakdown vs. Junction-Temperature

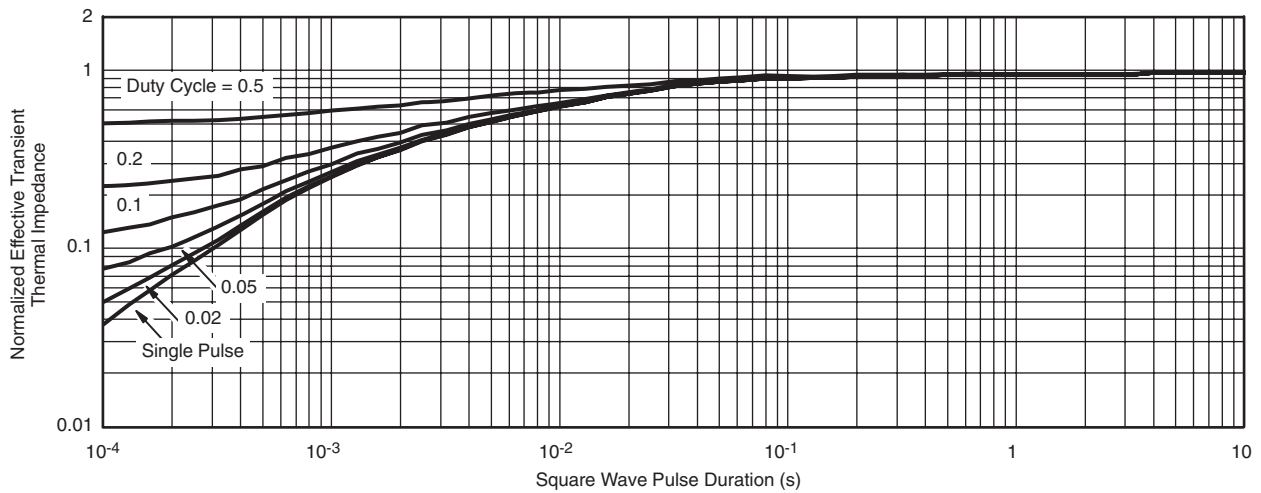

Maximum Avalanche and Drain Current vs. Case Temperature

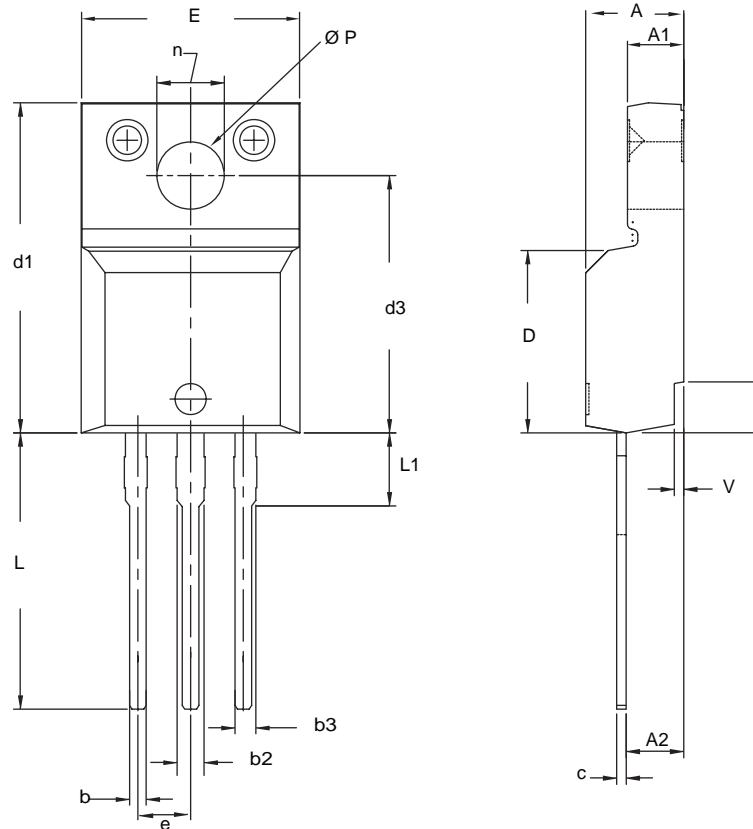
