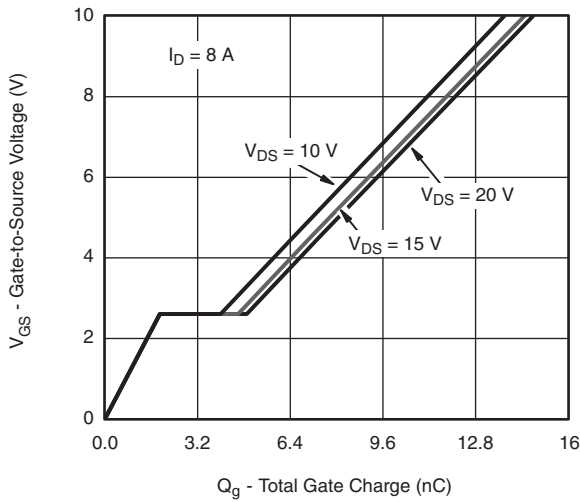

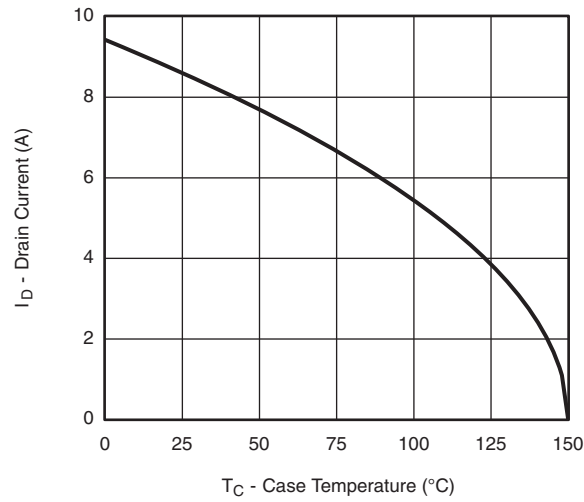
**On-Resistance vs. Junction Temperature**

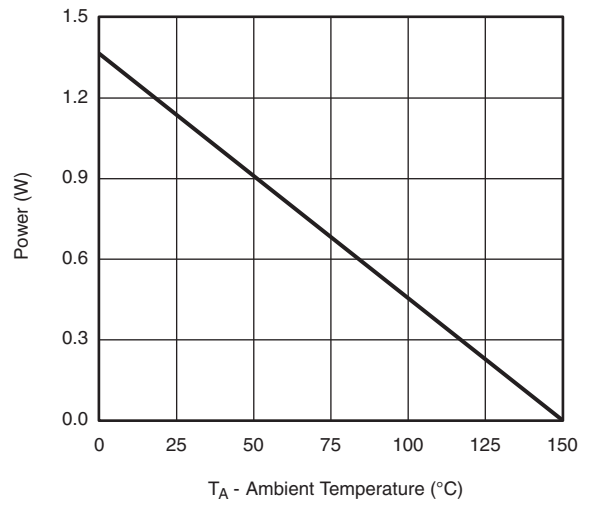

**Current Derating\***



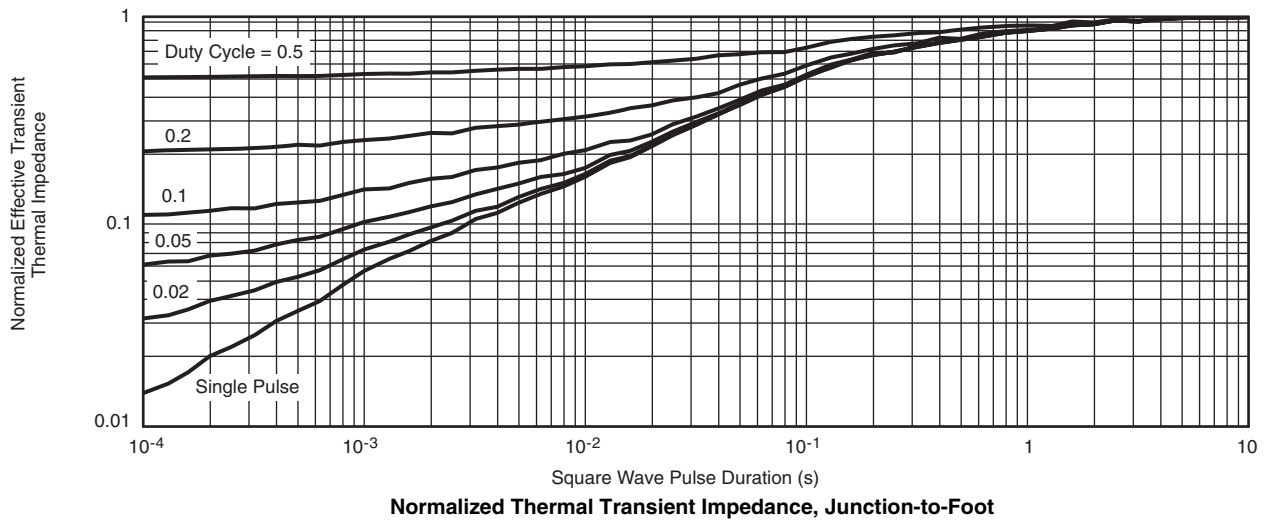
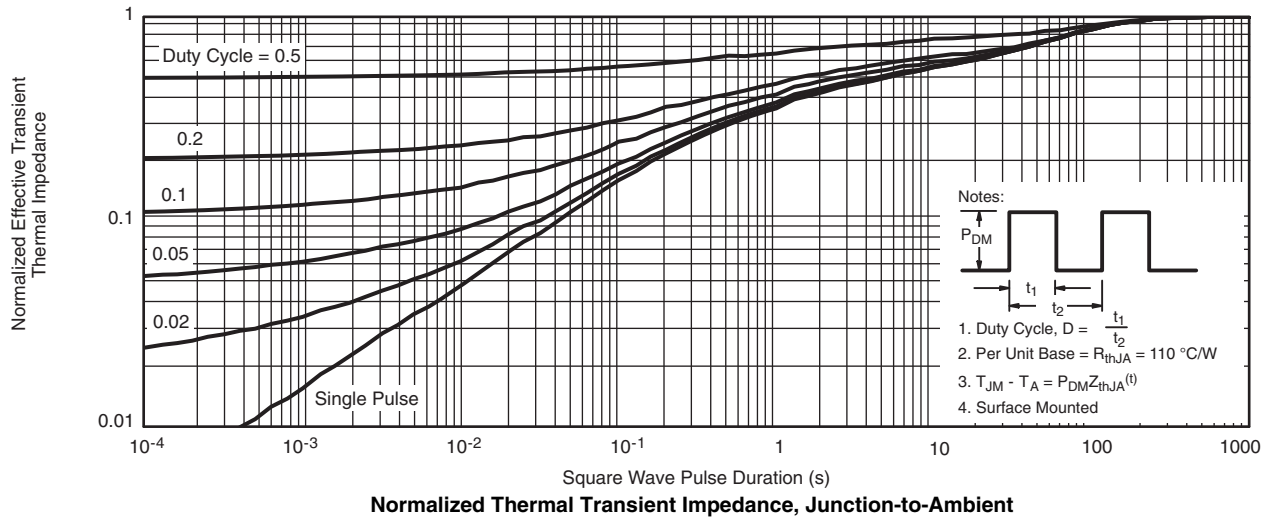
**Power Derating, Junction-to-Foot**
