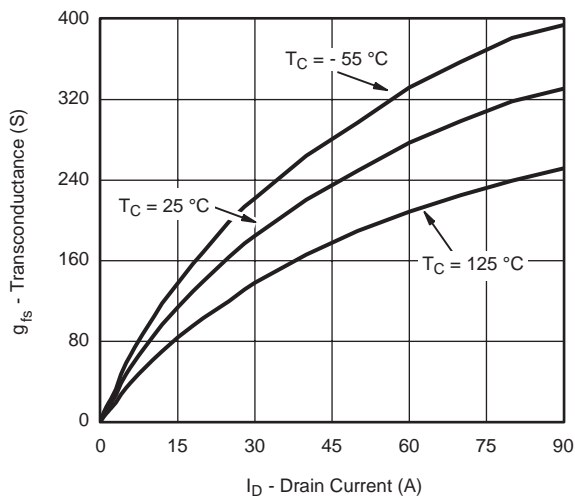

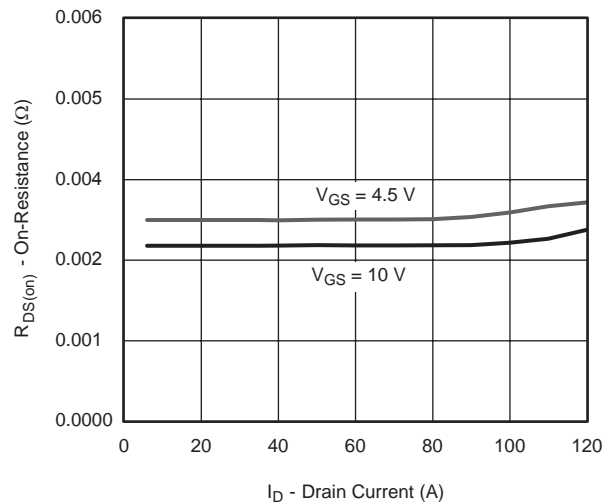
**Output Characteristics**



**Transfer Characteristics**



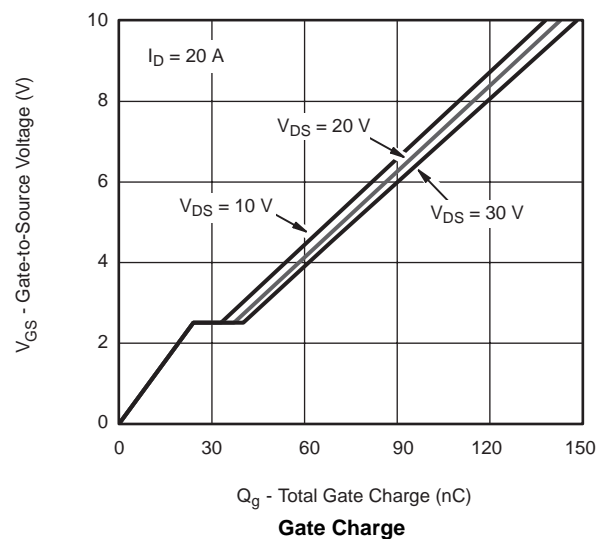
**Transconductance**

**Capacitance**

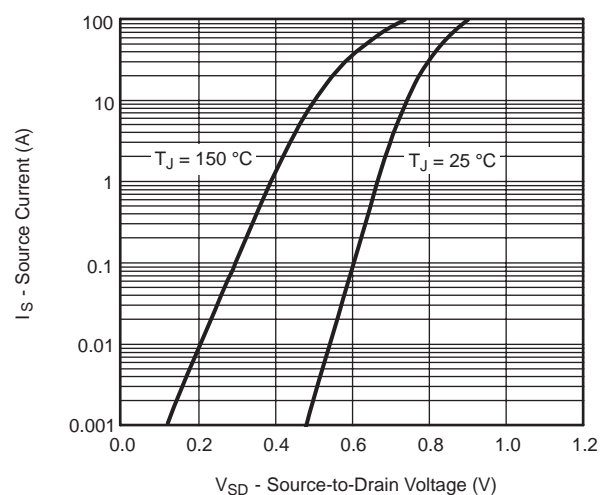
