










#### 7.2 Recommended Minimum PCB Layout

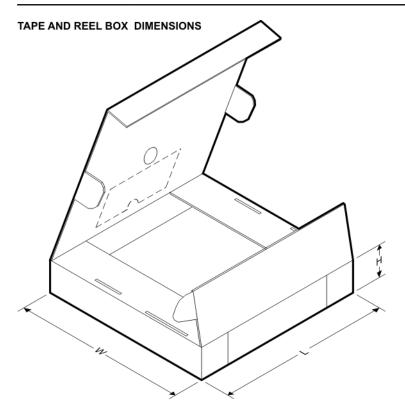
