









#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted



On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient










Normalized Thermal Transient Impedance, Junction-to-Foot


