Press-Fit Technology:

Follow all instructions in the datasheet, especially:

- · Drill-hole specifications.
- Wave and reflow soldering is not applicable.
- While press-fit process, PCB should be supported against bending.
- Chip formation due to material displacement is permitted.

Storage Conditions:

- Products shall be used within the period of 12 months based on the day of shipment.
- Do not expose the components to direct sunlight.
- The storage conditions in the original packaging are defined according to DIN EN 61760-2.
- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.


Packaging:
